An overview was given of Gomoto as was the inclusion program which went well this year.

**5.3 Overview of Whole of Sport Review**

Council and Managers meet next week. ALT and MA board not overly cohesive at present, some more work required and new board members needed to fill vacancies. Alliance agreement is nearly in place. Financial model sponsored by MWA (the user pays system) was not accepted after much work, though there is agreement for junior licences to be PAYG if technically can be achieved.
