Preface

This policy has been adopted to ensure that the duties of the Sweep Rider & Track Marking Volunteer are carried out proficiently and in accordance with Motorcycling Australia (MA) guidelines to ensure high safety standards are maintained at all MA/MWA permitted events. These volunteer roles are valuable in ensuring the highest standards of compliance are met and maintained for permitted events. **MWA recommend all volunteers hold operational level 1 accreditation.**

1. The following applies to all riders being considered for sweep duties

- 1.1 Sweep riders **MUST** be a minimum of 18 years of age.
- 1.2 Sweep rider **MUST** sign on to the Volunteers/Officials sign on sheet.
- 1.3 Sweep rider **MUST** attend Volunteers/ Officials Briefing.
- 1.4 If on public road area (such as anywhere in state forests, and other public land) the machine and rider **MUST** have the appropriate civil license.
- 1.5 Anyone carrying out the duties of Sweep Rider **MUST** have any of the following MA license; Annual Recreational, Senior National, Senior Restricted or One Event license.
- 1.6 Riders must be experienced riding off-road and regard given to their physical, mental capacity and capability to remain in control should and emergency arise.
- 1.7 Sweep Riders must receive instruction on their duties, including their roles and reporting. If required Sweep Riders should be given details of the evacuation/recovery plans, emergency procedures and be given maps and supporting documents.



- 1.8 Sweep Riders must be advised of the communication plan and must be given instructions on using radios/ phones or other equipment if required.

2. Sweep Riders duties include (but not limited to) ensuring

- 2.1 The track is free of hazards.
- 2.2 Track remains compliant.
- 2.3 All riders have vacated the track (MX).
- 2.4 All flag points are staffed (MX).
- 2.5 Emergency assistance can be given to injured riders and recovery of rider should it be necessary (off-road)
- 2.6 Communicate to the Clerk of Course, Chief Marshal or other relevant officials as required to ensure the smooth and safe running of events

3. Marking Out Volunteer for Enduro Events

- 3.1 Riders **MUST** be a minimum of 18 years of age.
- 3.2 Rider **MUST** sign on to the Volunteers/Officials sign on sheet.
- 3.3 Rider **MUST** attend Volunteers Briefing (if applicable)
- 3.3 If on public road area (such as anywhere in state forests, and other public land) the machine and rider **MUST** have the appropriate civil license.
- 3.5 Anyone carrying out duties of marking out or taking signage down for an enduro event, **MUST** have any of the following MA license; Annual Recreational, Senior National, Senior Restricted or One Event license.
- 3.6 Riders must be experienced riding off-road and regard given to their physical, mental capacity and capability to remain in control should and emergency arise.
- 3.7 Riders must receive instruction on their duties, including their roles and reporting
If required rider should be given emergency procedures, be given maps and supporting documents.
